- CONDITIONS OF AFFILIATION

1. The College shall implement each and every one of the recommendations of the Inspection Commission;
2. The 10.20 acres of land at Kalipattu Road, Thirukalikundram purchased by the Thirukalikundram Educational Research and Training Centre, Thirukalikundram should not be utilised for any purpose other than the above College purpose as per G.O. Ms. No. 389 Higher Education(E1) Dept. Dated 23.7.97.
3. The class room shall be according to the suggested U.G.C. Norms;
4. The Library should be strengthened, as suggested by the Inspection Commission. The Library shall have common reading room and stack room as per standard prescribed by the U.G.C. / State Government;
5. The Maximum number of student who may be admitted to each of the course shall not exceed the strength sanctioned by the University.

6. Laboratory shall be strengthened, as suggested by the Commission. The Laboratory shall have sufficient equipments required for performing experiments prescribed for the courses of study. The laboratories shall also have adequate arrangement for gas supply, regular water supply and electricity. The safety standard shall be fully observed;
7. Necessary Hostel accommodation, Staff Quarters, Play-Ground are to be provided;
8. Arrangement shall be made by the college for the conduct of University Examinations;
9. No donations shall be collected from the students seeking admission to any course of study in the College;
10. Excess admission shall never be made to any course over and above to the sanctioned strength of the respective course(s);
11. The Management of the College shall not discontinue any existing course without prior permission from the University
12. The College shall only collect Tuition and other fees from the students at the rates as prescribed by the State Government / University;
13. In the interest of standard of P.G. Education, the guidelines prescribed by the University for the P.G. Courses shall be followed. The admission to P.G. Courses will be considered on the guidelines determined by the Syndicate from time to time;
14. The guidelines with regard to infrastructure required for conducting the B.Sc Computer Science Course and qualifications for the teaching staff should be strictly adhered to;
15. The College should have [1] separate Lounge [2] Rest Room [3] Toilet [4] Women Faculty etc.,
16. A Librarian, Physical Director / Directress and a Medical Officer with the prescribed qualification shall be appointed;
17. Number of teaching and non-teaching staff shall be appointed as per norms prescribed by the University / U.G.C. / Government for each course including foundation course, allied and application oriented subjects;
18. No teacher shall be appointed, if he has not fulfilled the qualifications as laid down by the University and U.G.C. from time to time;

19. Teaching and Non-teaching staff shall be paid as per pay scales of State Government / U.G.C. prescribed from time to time;
20. An agreement shall be entered into with each teacher to be appointed as per the requirements of the University / Tamilnadu Private Colleges [Regulation] Act and rules thereunder;
21. The posts of teacher and Head of Departments wherever required for the proposed course shall be filled up before starting the course;
22. No teacher shall be appointed or shall be continued in service, who has attained the age of superannuation as may be prescribed by the Tamilnadu Government;
23. Suitable leave rules for teachers and Non-teaching staff be framed, generally in conformity with the State Government rules;
24. Approval shall be obtained from the University before appointing the teaching staff;
25. All conditions of affiliation laid down in Chapter XXVI Laws of the University Calendar, Volume-I 1985 as amended shall be strictly followed;
26. Such other Rules and Regulations as may be generally prescribed from time to time by the University shall also be complied with;
27. If all the conditions of Provisional affiliation granted are not complied with by the end of the period fixed then affiliation or approval shall cease automatically;

I am to inform you that provisional affiliation is granted to the above said courses for the academic year 1997-98 only, subject to the fulfilment of all conditions of affiliation especially No.2 of the conditions of affiliation and no student should be admitted for the next academic year (i.e. for 1998-99) without getting prior orders extending the provisional affiliation by one more year from the University.

I am also to inform you that the admission of candidates into I year of the above said courses should be made on or before 26.11.97 and the candidates admitted for such courses should earn the required percentage of attendance prescribed for the University Examinations.
